Alan has written extensively on product liability and class action litigation and served as co-author for two journals on audit committees. He is a lecturer at the CPA Club for Continuing Professional Experience, where he speaks on developments in the law as it impacts certified public accountants and other accounting professionals.

## Select Engagements

- A multinational chemical company, as national lead trial counsel in the defense of over 150 environmental pollution and product liability cases in multidistrict litigation involving water contamination in cities within 17 U.S. states; to date, the company's share of settlements has been less than one-half of one percent.
- A large national mortgage company, in a breach of contract and RICO action where damages were sought for \$26 million. The seven-day trial resulted in a verdict for the mortgage company and success on its cross-claim; the case was settled.
- A large national bank, defended in a breach of contract action involving the sale of 12 bank branches following a Department of Justice-mandated divestiture of bank branches.
