Christopher Lewis concentrates his practice on energy and public utility law, representing utilities, electric generation suppliers, developers, and others in regulatory proceedings, litigation, and transactional matters.

Chris is the current chairman of the Philadelphia Energy Authority, a member of the board of commissioners for the Delaware River Port Authority, and a trustee on the Council of Trustees of West Chester University of Pennsylvania. He also currently serves as a member of the Federal Judicial Nominating Commission for the Eastern District of Pennsylvania, which screens candidates for Senators Casey and Toomey in connection with potential appointments to the federal bench.

Chris is a 1975 graduate of Harvard College, B.A. in Government, *magna cum laude*, and a 1978 graduate of the University of Michigan Law School, J.D., *magna cum laude*. He served in Governor Robert P. Casey's administration from 1989 to 1991 as secretary of the Commonwealth of Pennsylvania, the agency head for Pennsylvania's Department of State, and as executive deputy in the Office of General Counsel from 1987 to 1989.

In 2000, Governor Ridge appointed Chris to the Judicial Conduct Board of the Commonwealth of Pennsylvania, the state agency that investigates and prosecutes judges for ethical misconduct. In 2004, Chris served as chair of the Judicial Conduct Board.

In 2008, Chris was selected as an elector for the 2008 Electoral College. He was a member of the National Finance Committee for President Barack Obama, as well as

a delegate to the Democratic National Convention, pledged to Senator Obama, and elected from the 7th Congressional District in Pennsylvania.

Chris serves as Blank Rome's Chief Diversity and Inclusion Officer Emeritus and as an emeritus member of our firm's Diversity & Inclusion Committee.
