Select Engagements

- Resolved complex, high-profile criminal and civil proceedings successfully for a publicly traded medical device manufacturer in challenging cases receiving national media attention.
- Lead trial counsel for various cases around the country, including a recent unanimous defense verdict in Philadelphia’s first talc products liability trial for the world’s largest healthcare company.
- Achieved a favorable settlement for the defense in a case alleging violations of the Alien Tort Statute—litigation that was followed by the national media and referenced in a *New York Times* best seller, which involved enhanced interrogation techniques for high-value detainees captured in foreign countries.
